## **EXISTING REGISTERED MEDICAL PRACTITIONERS**

## FOR REGISTRATION NUMBERS 40001-75000

A notification was issued on 31st August 2020 by the Tamilnadu Medical Council directing all the Registered Medical Practitioners with registration numbers between 40001 to 75000(Registered in TNMC on or before 05.01.2020) to update their credentials online and obtain fresh e-certificates of their registered degrees on or before 31.01.2021.

As directed by MCI, this updation is to create a "State Medical Digital Register" to contribute to the formation of "National Digital Medical Registry" which is a part of National Digital Health Mission.

This update shall apply to all Registered Medical Practitioners with registration numbers between 40001 to 75000 and it is reiterated by the council that the updation shall be mandatorily done on or before 31.01.2021.

The above matter was brought to the notice of the Tamil Nadu Medical Council in the General Business Meeting held on 10.12.2020 and the subject was discussed in detail by the council and it has been resolved by the council that,

- 1.All registered medical Practitioners with registration numbers between 40001-75000, have to mandatorily update their credentials for creation of State Digital Medical Register and obtain fresh e-certificates on or before 31.01.2021.
- 2.To impose a delayed update fees of Rs 10000/- in addition to the normal updation fees, on or after 01.02.2021.

All RMPs are requested to cooperate in this digital update.
